PRIVACY POLICY

Mountain House Developers, LLC and our affiliates and subsidiaries (collectively, "MHD", "we", "our", and/or "us") value the privacy of individuals who use the websites, apps, and affiliated services that we own and operate (collectively, the "Services"). This privacy policy (the "Privacy Policy") explains how we collect, use, and share information from or about users of our Services ("Users") or their devices. By using or accessing our Services, you agree to the collection, use, disclosure, and procedures this Privacy Policy describes. Beyond the Privacy Policy, your use of our Services is also subject to our Terms of Service.

Unless otherwise specified, MHD includes Mountain House Developers, LLC and all affiliated companies. This Privacy Policy applies to all MHD Services, including mountainhousematters.com and any mobile application provided by or on behalf of MHD.

1. INFORMATION WE COLLECT

As part of the normal operation of the Services, we may collect a variety of information from or about you or your devices from various sources, as described below.

If you do not provide your information when requested, you may not be able to use all the functionalities of our Services if that information is necessary to provide you with access to our Services or if we are legally required to collect it.

INFORMATION YOU PROVIDE TO US

If you create or update profiles on our Services, sign up for notifications or updates, log into your account, register for sweepstakes or contests, or participate in demos or surveys, we may ask for information about you including, but not limited to, your first and last name, home address, email address, cell phone number, home telephone number, work telephone number, fax number, and any other information we collect. If you sign up using a third-party social media account, we may also receive information from those third parties, such as your name, email address, gender, date of birth, profile photo, preferences, friends, and information that you agree to share with us at the time you give permission to link your accounts.

INFORMATION WE COLLECT WHEN YOU USE OUR SERVICES

We receive information about the device and software you use to access our Services, including internet protocol ("IP") address, web browser type, operating system version, phone carrier and manufacturer, installed applications, device identifiers, mobile advertising identifiers, and push notification tokens.

INFORMATION WE RECEIVE FROM THIRD PARTIES

We may share or otherwise disclose information we collect from or about you as described below or otherwise disclosed to you at the time of collection.

We may share any information we receive with or among MHD's subsidiaries and affiliates for any of the purposes described in this Privacy Policy.

We may share any information we receive with vendors and service providers retained in connection with the provision of our Services.

Our Services include social services such as discussion boards, bulletin boards, blogs, and referral functions in which you can find, enjoy and share content. Your name, username, and other profile information will always be viewable. The content you post to the Services will be displayed on the Services and viewable by others by default.
